Code § 30130.56(e)) TEROC advises the California Department of Public Health, the University of California, and the California Department of Education with respect to policy development, integration, and evaluation of tobacco education programs (funded by Proposition 99 and Proposition 56). TEROC is also responsible for the development of a master plan for the future implementation of tobacco control.
