## About Our Community - Health Starts Where We Live, Learn, Work, and Play

1. Geography: Imperial County is a unique rural community located in the southeast corner of California, bordered by Riverside and San Diego Counties, State of Arizona, and Mexico. It covers 4,176 square miles of desert land with about 1,000 square miles dedicated to irrigated farmland. The climate fluctuates throughout the year from very hot ( $<100$ 。 F) summer months to relatively mild and low temperatures in the fall, winter and spring.
2. Major industries and employers: According to the California Employment Development Department, the major industries and employers in Imperial County include: power plants (Calenergy Operating Co. \& Vulcan-Bn Geothermal Power); government offices (County of Imperial, Calipatria State Prison, Centinela State Prison, U.S. Border Patrol, \& El Centro Naval Air Facility); hospitals \& clinics (El Centro Regional Medical Center, Pioneers Memorial Healthcare \& Clinicas de Salud del Pueblo, Inc.); schools (Imperial County Office of Education, Central Union High School, \& Academic Services); distribution services (Imperial Irrigation District); casinos (Paradise Casino); sugar refiners (Spreckels Sugar Company Inc.); gypsum (United

States Gypsum); home centers (Home Depot); seeds \& bulbs (Allstar Seed Company); \& labor organizations \& contractors ( 8 A Packing LLC \& Jjall LLC).
3. Walkability and recreational areas: There are approximately 4 recreational facilities in Imperial County per 100,000 residents, and of the total population, $0.41 \%$ lives within $1 / 2$ mile of a park. A total of $28 \%$ of adults engaged in regular walking in the past week, and $77 \%$ did not exercise in the past month. Sixty-two percent of children/teens were sedentary 2 or more hours on a typical weekday \& only $23 \%$ of children ages 5-11 \& $15 \%$ of teens 12-17 engaged in daily physical activity.

## Health System - Health and Human Services for the MCAH Population

Imperial County has 2 hospitals where women give birth: El Centro Regional Medical Center and Pioneers Memorial Hospital. Imperial County does not have CPSP providers at this time, but it does have 17 Denti-Cal providers for children. Local challenges to accessing medical, mental, dental and social services includes, but are not limited to, transportation and childcare services.

Local programs that address health and human services for the MCAH population, include, but are not limited to the following: Adolescent Family Life Program; Home Visiting Program; Perinatal Care Guidance Program; Cal-Learn; Women, Infants and Children (WIC) Program; Planned Parenthood; Imperial County Children and Families First Commission; and Clinicas de Salud del Pueblo, Inc.

Public health issues that impact multiple MCAH population groups include, but are not limited to, access to healthcare services (medically under-served area, transportation barriers, etc.), chronic disease (obesity, diabetes, heart disease, asthma, etc.), socio-economic status (poverty, unemployment, etc.), and health behaviors (teen pregnancy, food insecurity, physical inactivity, etc.).

## Health Status and Disparities for the MCAH Population

Low socioeconomic status and high rates of unemployment and poverty impact access to health care, including access to early and adequate prenatal care. Those factors are also key to overweight and obesity in low-income and poor families: poorer neighborhoods lack grocery stores, farmers markets and have a greater number per capita of fast-food eateries which directly impact this population's ability to access healthy foods. Also, there are fewer parks and recreational facilities in disadvantaged neighborhoods, thus limiting their access to healthy and safe physical environments.

In 2015/2016, local key stakeholders, community members, and advocates convened to participate in its first comprehensive and collaborative Community Health Assessment and Community Health Improvement Planning process. Currently, Imperial County is finalizing its Community Health Improvement Plan (CHIP) in which it will address community health problems in a more coordinated and resourceful way. This marks the beginning of a new era in Imperial County to help improve health outcomes in our community through the implementation strategies that are aligned with MCAH and other local efforts.
