This new custom-designed data system will replace ARIES in Fall 2023. The name reflects the goal of the system: to connect clients to care in an easier and more efficient way. Action Needed by ARIES Users

To help prepare for the launch of HCC, we would like agency managers to review and confirm the contact person on their Agency screen in ARIES. We would like one point of contact at each agency who OA can communicate with regarding the rollout of HCC. OA will reach out to agency contacts for assistance with tasks such as identifying and validating active user information, distributing information to agency staff, and sharing feedback from users. The contact may be any individual from the agency – a manager, an IT specialist, a technical lead, a data specialist, or another staff member. 

Access selected ADAP and lab data to help coordinate care







Instructions for Confirming Agency Contact Information in ARIES

- 1. Log into ARIES.
- 2. Go to Shortcuts and click on My Profile. Once your profile shows up, click on the hyperlink for your agency. Agency Info tab will show up.



3. On the AGENCY INFO tab, select the **Edit** button.



4. The Agency Edit screen will open.



- 5. Review the Contact Name, Title, Email, and Phone fields.
 - a. If any of this information is outdated, type in the new information and click the **Save + Done** button.

- b. If the information is current and correct, click the **Save + Done** button. Do not click the CANCEL button.
- 6. If there are additional changes during 2023, please update ARIES as soon as possible. We ask that you do not make other edits to this screen particularly the Agency Name at this time.
