ADVISORY STATEMENTS

- The Trauma Scene Waste Management Practitioners listed below are registered with the Department of Public Health pursuant to Section 118321 of the Medical Waste Management Act. (California Health & Safety Code)
- The Act defines trauma scene waste as waste regulated by the Cal/OSHA Bloodborne Pathogen Standard, that "...has been removed, is to be removed, or is in the process of being removed, from a trauma scene by a Trauma Scene Waste Management Practitioner." (Section 117777, Health & Safety Code).
- A Trauma Scene Waste Management Practitioner is a person (including companies) that provide trauma scene clean-up services commercially. That is, they are paid for their services. These persons must, by law, register with the Department.
- Because the definition of waste as trauma scene waste depends on its management by a Trauma Scene Waste Management Practitioner, persons who volunteer to clean such sites (a neighbor or family member, for instance), or who clean scenes that might emerge outside the usual course of primary job duties (for example, properly OSHA-trained police, fire, safety, and janitorial personnel) and are NOT specifically hired to attend to a given trauma incident, do not fall under the Act. That is because the waste they are removing is not, by definition, trauma scene waste.
- **FOR THE PUBLIC:** Registration as a Trauma Scene Waste Management Practitioner (TSWMP) does not carry any expressed or implied endorsement by the Medical Waste Management Program, Department of Public Health (Department) of the quality of work and/or service provided by the TSWMP; nor does the Department set the fees for the work performed by the TSWMP. If you are a renter or a homeowner and you have a homeowner's or renter's insurance policy, you should contact your insurance agent for information about possible coverage for work performed by the TSWMP. TSWMP Registration is a completely separate process from the licensing activities of the Contractors' State License Board. Under current law, the Department DOES NOT require a TSWMP to possess a contractor's license as part of its registration application. However, some restoration jobs may require a licensed contractor. - Program staff make every effort to maintain an accurate list of Practitioners, but extensions of expiration dates, pro-rating of fees, or re-issuance of expired registration numbers are all against Program policy. The Program periodically updates public agencies with copies of the list, but cannot guarantee that these agencies will actively maintain all subsequent updates to the list. See the Program website:
