I. OTS Summit – Resources/Information

What a great conference! For those of you who attended, it was terrific to see you! The themes that really rang true were DATA and EQUITY! I appreciated these references for overarching work on equity in transportation:

- US Dept of Transportation Equity Plan
- Caltrans Transportation Equity Index

Our CPS session focused on equity and included a presentation by Christine Li, LA County Public Health Transportation Safety Manager, where she overlaid GIS of LA County population with the Healthy Places Index. This allowed Christine to evaluate her local partnerships and highlight which areas she was already reaching, and which areas needed more partnerships to provide critical CPS services. Christine used the Healthy Places Index and GIS mapping by county/city and her helpful map is provided below.

Attached is a spreadsheet that VOSP developed for the CPS session, that can provide all of us a better understanding (and maybe something useful in your OTS grant applications) of how many technicians/instructors we have in our counties/state, and where our resources are with special needs trained technicians and Spanish speaking

technicians. Included are the child populations broken down into categories we can agree upon such as 0-7 (to be in a car or booster seat), 8-12 (in the back seat and likely in a booster until 10), and 13-15 (pre-driver and learning how to be a good occupant). These ages incorporate all the CPS Vehicle Codes 27360 (ages 0-7), and 27360.5 (8-16 years) where the parent or driver in the vehicle would receive a citation if the child was not appropriately restrained.

Also included in this newsletter below, is the map of Tribal Groups pre-1849, which was emailed to you in October that can help all of us in California to identify where our tribal lands/people overlay with our counties. 
