SUBJECT: FISCAL YEAR (FY) 2007-08 CERTIFICATE AND ALLOCATION TABLE

Enclosed is the certificate for State Financial Assistance and a table showing SPHS allocations calculated pursuant to the Budget Act of 2007, Chapter 171 (Senate Bill 77). The total allocation for FY 2007-08 is \$1 million. You may access the allocation table and certificate by double-clicking on the hyperlinks listed on page two.

The allocations are intended to promote the provision of necessary public health services by granting financial assistance to cities, counties, and local health districts. These funds shall be used as specified in the Health and Safety Code, Section 101230, Subdivision (d) (1) and (2). The Office of County Health Services (OCHS) will distribute the funds to each participating city and county in quarterly payments during FY 2007-08.

To participate in the program, the local health officer's signature is required on the certificate. If a person other than the local health officer signs the certificate, please attach a letter that grants the person authority to sign. The certificate is due by **November 1, 2007**, in order to begin processing the quarterly payments.
