The purpose of this memorandum is to provide an update on a recent change that has occurred in your county since the issuance of ADAP Management Memo No. 2012-05 on July 23, 2012 regarding ADAP eligibility screening for the Low Income Health Program (LIHP).

Revised LIHP Federal Poverty Level (FPL) for Placer County

The LIHP in Placer County has increased their qualifying FPL, as follows:

All ADAP applicants who may qualify for LIHP must be referred to apply to LIHP **EXCEPT** for applicants with private insurance or Medicare Part D. ADAP will continue to cover any prescription co-pays and/or medication deductibles for private insurance and Medicare Part D clients, whether or not they are co-enrolled in a county LIHP, since county LIHPs cannot cover these costs.
