# HOAC Supported Bills

- ▣ SB 792 (Mendoza) (Sponsored)
  - Vaccines for day care workers
- ▣ SB 203 (Monning) (Co-Sponsored)
  - Warning labels on sugar drinks
- ▣ SB 277 (Pan)
  - Eliminating the personal belief exemption for vaccines
- ▣ AB 11 (Gonzalez)
  - Employment: paid sick days: in-home supportive services

(cont'd)

# HOAC Supported Bills (cont'd)

- ▣ AB 908 (Gomez)
  - Paid Family Leave
- ▣ AB 1207 (Lopez)
  - Training for mandated child abuse reporting
- ▣ SB 140
- ▣ SB 591
