FFY 2015 WRO Management Evaluation – *Gil Sisneros*

- Eight local health departments have been selected for a WRO Management Evaluation
 - Los Angeles
 - Orange
 - Colusa
 - Santa Clara
 - San Diego
 - Tulare
 - Monterey/San Benito
- The will take place between January 20, 2015 and February 6, 2015.
- NEOPB has communicated with the respective LHDs on timelines and instructions to prepare for WRO Management Evaluation. NEOPB is conducting an informational call with the LHDs scheduled to be part of the 2015 WRO Management Evaluation.

- Planning among the State Implementing Agencies (SIAs) has begun for the Spring Forum, tentatively scheduled for March.
- Pre-Forum webinars will be scheduled to assist LHDs and other Local Implementing Agencies prepare for the forum's activities and sessions.

Retailer List – *Caroline Kurtz*

- FNS releases the annual list of retailers who redeem a certain percentage of EBT sales per month
- The retailer list is confidential and needs to be requested of WRO through CDSS.
- NEOPB is currently working with CDSS to obtain the current retailer list.
- NEOPB staff is then able to cross-check retailers LHDs are interested in working with to the list for site qualification purposes.
- LHDs submit their questions and requests through their designated NEOPB P.O.

LHD Communications - *Cyndi Walter*

- Beginning January 2015, NEOPB will be sending a standardized e-newsletter to the LHDs

 - Be sent out 2x a month to begin with
 - Replace multiple email blasts from NEOPB to LHDs
