The MCAH Division is pleased to announce the successful applicants and annual funding award amounts for CA PREP for fiscal years 2015-2018.

Awards are contingent upon federal PREP funding levels, contract negotiations, and state spending authority. Funding is based on tier levels outlined in the RFA instructions, as well as applicant plans to deliver services. Prior to and during contract negotiations, applicants will be required to submit additional budget and contract information to meet the RFA requirements. Upon completion of contract negotiations, a contract will be executed and shall commence on July 1, 2015.

CDPH/MCAH received 49 applications, of which the following 22 were selected for funding. The RFA process was highly competitive, and CDPH/MCAH wishes to thank all applicants for their thoughtful proposals and commitment to promoting teen pregnancy prevention efforts in California.
