

# FARMER - VENDOR APPLICATION & AGREEMENT

WIC and Senior Farmers' Market Nutrition Program (FMNP)  
and/or  
WIC Fruit and Vegetable Check (FVC)

## Instructions

Incomplete information will delay your application approval.

1. Complete the following sections.

### Section 1: Certified Producers Information (farmer)

- Certified Producer Information: print farm name, certified producer's name(s), mailing address, at least one phone number. This information must match your Certified Producer's Certificate.
- Producer's Certificate Information: print the name of the county that issued your Certificate, the certificate number and the date the Certificate expires.

### Section 2: Market Manager Verification of Producer's Certificate Information

- You must have a Market Manager at one of the WIC authorized markets where you sell produce sign your application to confirm your information or you may send a copy of your Producer's Certificate with your application.

### Section 3: Training Requirement

- New FMNP Applicants: must be trained by WIC Authorized Market Manager, Local WIC Agency Staff, State WIC Staff or register and attend a Webinar training. The trainer must print name, title, date and must sign section 3. If training was via webinar print the registration ID # and date
- Re-Authorizing FMNP Applicants: must check the box to verify that they have reviewed the FMNP newsletter or other FMNP materials to meet training requirements.
- New and Re-Authorizing FVC and FMNP Applicants: are **REQUIRED** to attend a Face-to-face or interactive (webinar) training by State WIC Staff every 3 years. If trained in person the trainer must print name, title, date and must sign section 3. If Training was over the phone include trainers name, title and date. If training was via webinar print include the registration ID # (you received via email when you registered) and date.

### Section 4: WIC Authorized Farmers' Market Locations Where You Sell Produce

- List all WIC Authorized Farmers' Market number (#), Market names, locations, city, county and days and hours of operation. WIC Authorized Farmers Markets and #'s can be found at [www.wicfarmers.ca.gov](http://www.wicfarmers.ca.gov) under WIC Authorized Farmer and Market Lists. The first market listed must be the market of the Market Manager who has verified your information on this application. You may attach additional sheets if necessary.

### Section 5: Certified Producer (Farmer) Agreement and Signature

- Sign and date the application and agreement. The signatures must coincide with the Certified Producers name(s) provided in Section 1. By signing the application, you agree to follow all program requirements in the Application and Agreement.

2. Keep a copy of pages 1 and 2 of the Application and Agreement for your records.
3. Read and keep Sections 6-8 on pages 3 and 4 of the Application and Agreement.
4. **Mail** pages 1 and 2 of the Application and Agreement to the address at the top of page.
