**VENDOR ALERT 2013 - 01**

TO: ALL WIC VENDORS  
SUBJECT: GERBER® INFANT CEREAL CHANGES

**Purpose**

Nestlé is changing the package type for its Gerber® infant cereals from boxes to plastic containers. They are also changing the name of their Mixed Grain infant cereal to MultiGrain. The package sizes will remain the same, though the new packages will have new Universal Product Codes (UPC).

**Background**

Though the package type is changing and the products are being slightly reformulated, participants can continue to purchase Gerber® infant cereal products, as listed in the July 5, 2011 WIC Authorized Food List Shopping Guide (WAFL SG). Additionally, participants can continue to purchase the Mixed Grain infant cereal when the name changes to MultiGrain; this name change will be reflected in the next reprinting of the WAFL SG. There will be no Food Instrument changes. Products with the new packaging will begin to appear on store shelves in March 2013.
