

## WIC ISIS CHANGE CYCLE APRIL 28, 2014

The following changes are now available in ISIS production as of April 28, 2014.

### 1. Fixes to PRONTO Field

- ISIS is now saving all PRONTO entries.
- For all new HGB values beginning April 28, ISIS will require a valid PRONTO entry.

### 2. Formula Name Changes

- Mead Johnson has removed the word “Premium” from their products. Products with the new name began shipping mid-April and will be available on retailer shelves in May. The old and new names will be on the food instruments for approximately one year due to the overlap on the product labels. See example of FI below.
