SUBJECT: Radiologic Technology Act Regulations, DPH-10-014

PUBLIC PROCEEDINGS: Pursuant to Government Code section 11346.8(c) and title 1, California Code of Regulations, section 44, notice is hereby given that the California Department of Public Health (Department) has changed the text of the proposed regulations regarding Radiologic Technology Act Regulations, DPH-10-014, and is making the changed text available for public comment prior to adoption, amendment or repeal of the resulting regulations.
