CROSS FILING INFORMATION	If you meet the entrance requirements for this classification and for Examiner I Laboratory Field Services, you may file for both examinations on a single application. You must indicate the class title(s) for each examination you are applying on the application Form STD. 678.
FINAL FILING DATE	There is no final filing date. Testing is considered continuous as dates can be set at any time. The testing office will accept applications continuously and will notify and test applicants as needs warrant.
TESTING PERIOD	A candidate may be tested only once during any testing period. The testing period for this classification is January 1 through December 31.

WRITTEN TEST DATE	Written test dates will be set as needed, and will be administered in Los Angeles and Contra Costa Counties. Applicants will be notified, by mail, of specific date, time, and location of the written test.

POSITION DESCRIPTION	<p>This is the staff specialist level of the Examiner series. Under general direction, the incumbent develops and administers a complex area of Laboratory Field Services, such as evaluation of licensing personnel, biologics licensing, and evaluation and approval of clinical laboratory training facilities; provides guidance in his/her area of specialization to Examiners I, Laboratory Field Services; and performs other related duties.</p> <p>Positions exist with the Department of Public Health in Los Angeles and Contra Costa Counties.</p>
REQUIREMENTS FOR ADMITTANCE TO THE EXAMINATION	<p>It is your responsibility to make sure you meet the education and/or experience requirements stated on this announcement on the date you submit your application. Your signature on your application indicates that you have read, understood, and possess the basic qualifications required.</p> <p>NOTE: Applications/resumes must include "to" and "from" dates (month/day/year), time base, civil service class title(s), and range (if applicable) for all work experience. College course information must include title, semester or quarter units, name of institution, completion dates, and degree (if applicable).</p> <p>Applications/resumes received without this information will be rejected.</p>
MINIMUM QUALIFICATIONS	<p>Qualifying experience may be combined on a proportionate basis if the following requirements include more than one pattern and are distinguished as either I, or II, or III, etc.</p> <p>Possession of a valid license as a clinical laboratory bio-analyst or scientist, or certification as a public health microbiologist issued by the California State Department of Public Health. (Applicants who do not possess the required license or certification will be admitted to the examination, but they must secure a license or certificate before they will be considered for appointment.) And</p> <p style="text-align: center;">Either I</p> <p>Two years of experience performing the duties of an Examiner I, Laboratory Field Services, in California state service.</p> <p style="text-align: center;">Or II</p> <p>Possession of a master's degree in clinical laboratory science clinical chemistry, medical microbiology, or public health. and</p> <p>Five years of increasingly responsible experience in a clinical or public health laboratory, three years of which must have involved one or a combination of the following:</p> <ol style="list-style-type: none"> 1. Field consultation experience in the clinical or public health laboratory field; or 2. Supervisory experience involving supervision of professional laboratory personnel or as a laboratory director; or 3. Performance as a staff specialist in one or more of the technical areas of clinical or public health laboratory science. (Post-baccalaureate graduate work in clinical chemistry, medical microbiology, clinical laboratory technology or public health may be substituted on a year-for-year basis for not more than two years of the required general experience.)
GENERAL QUALIFICATIONS	<p>Candidates must possess essential personal qualifications including integrity, initiative, dependability, good judgment, ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required.</p>
EXAMINATION INFORMATION	<p>The examination will consist of a written test weighted 100%. Candidates who meet the requirements for admittance to the examination (minimum qualifications) will be scheduled to take a written test. Competitors who do not appear for the written test will be disqualified and eliminated from the examination process.</p> <p>The California Department of Public Health reserves the right to revise the examination plan to better meet the needs of the service if circumstances under which this examination was planned change. Such a revision will be in accordance with civil service law and rules and all competitors will be notified.</p>
WRITTEN TEST SCOPE	<p>In addition to evaluating the candidate's relative abilities as demonstrated by quality and breadth of experience, emphasis will be placed on measuring, relative to job demands, each competitor's:</p> <p>Knowledge of:</p>

Technical areas of clinical or public health laboratory sciences, such as clinical chemistry, toxicology, bacteriology, immunology, mycology, hematology, parasitology, cytology, or virology, including principles, techniques, equipment and terminology used in the laboratory investigation of diseases. 2. The causes and methods of transmission and control of communicable diseases. 3. Current developments in clinical and public health laboratory sciences. 4. State and Federal laws and regulations relating to clinical and public health laboratories, biologics production, and proficiency testing services. 5. Use of available scientific information technology and available scientific resource materials. 6. Specific application of laws and regulations relating to clinical and public health laboratories, including principles and procedures involved in the investigation of violations and current developments in legislative action affecting clinical and public health laboratories and personnel. 7. General principles of effective leadership. 8. Principles and practices of organization and management as applied to a laboratory program or activity. <p>Ability to:</p> <ol style="list-style-type: none"> 1. Perform clinical laboratory tests, microbiological analysis, or other specialized technical procedures. 2. Conduct surveys and investigations of clinical and public health laboratories, blood banks, and other specialized facilities with accuracy, thoroughness, and tact. 3. Interpret and apply laws and regulations to specific cases. 4. Communicate and consult with laboratory personnel and administrators. 5. Collect and organize data for hearings. 6. Organize specialized activities or programs. 7. Prepare complex reports, guidelines, and proposed regulations.
ELIGIBLE LIST INFORMATION	<p>In order to obtain a position on the eligible list, a minimum rating of 70% must be attained. Names of successful competitors are merged into the list in order of the final scores regardless of date. Eligibility expires 24 months after it is established unless the needs of the service and conditions of the list warrant a change in this period.</p> <p>Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) service-wide promotional, 5) departmental open, and 6) open. When there are two lists of the same kind, the older must be used first.</p>
VETERANS PREFERENCE	<p>Veterans preference credits will not be granted in this examination since it does not qualify as an entrance examination.</p>
