## Liaison Instructions for submitting the CalREDIE Neurodegenerative Reporter Account Authorization Form

Once you have received the CalREDIE Neurodegenerative Reporter Account Authorization Form with Section 1 complete, please complete Sections 2 and 3. Verify that the Report Source(s) have been entered in the Report Source Dictionary correctly, following the data standards listed below. If the entry does not exist in the Report Source Dictionary already, proceed to completing the [Report Source and Location Dictionary Request Form](#) on the CalREDIE Help Page. Submit completed forms to [CalREDIEHelp@cdph.ca.gov](mailto:CalREDIEHelp@cdph.ca.gov).

**Report Source Dictionary Standards for Provider Portal User Accounts (two scenarios):** It is important to remember to always complete a thorough search for a provider or facility/laboratory before requesting a new entry in the dictionary. Remember, the less information used in the search, the more results CalREDIE will return.

1. **Provider Portal User accounts with 5 or fewer providers:** A Provider Portal user account can be linked up to 5 Report Source Dictionary entries (i.e. 5 different providers). Please note that while the provider may be the one requesting a Provider Portal User account, not all Provider Portal Users will be Providers (e.g. Office staff can request a PP User account to perform data entry tasks on behalf of the provider).
  - **Report Source Standard:** Last Name, First Name Middle Name, Credentials - Submitter
    - Example: Mari Jo Dedeker, a physician's assistant works for Andersen Medical Associates.
    - Provider field = Dedeker, Mari Jo, PA - Submitter
    - Link to Location Dictionary entry "Andersen Medical Associates"
  - **Please Note:** *If a provider is associated with multiple facilities, multiple entries for the provider must be created in the Report Source Dictionary to reflect these different associations. A Report Source Dictionary Entry should not be associated with more than one location. Each entry for the provider will be associated with a different Location (facility) in the Location Dictionary. A hyphen with the facility name should be used after the provider's name (Last Name, First Name, Credentials – Facility Name) to help identify the correct provider when searching the Report Source Dictionary. Please refer to the [CalREDIE Reference Guide: Standards, Protocols & Guidelines](#) on the CalREDIE Help Page for more information.*
  
2. **Provider Portal User accounts with over 5 providers:** Resort to this when requesting an account for a large facility.
  - **Report Source Standard:** Same facility name as the Location Dictionary – Submitter
    - Example: An ICP at Sutter Medical Center will be submitting incidents via the Provider Portal for numerous physicians.
    - Provider field = Sutter Medical Center – Submitter
    - Link to Location Dictionary entry with the same name "Sutter Medical Center"
  - **Please note:** *For facilities with a commonly used name, a hyphen followed by the city, town or neighborhood should be used. In instances where a facility has more than one location in a city, a descriptive identifier can be used. Example: "Kaiser Permanente – Napa – Submitter".*
