

Preliminary Monthly Statewide Violence-Related Death Counts

All data below are preliminary based on the date the data were extracted. These counts may not represent all violence-related deaths that occurred during the corresponding time period.

Date Report Produced: 12/11/2023

Data Notes:

- Deaths occurred in California (residents and non-residents). Counts exclude deaths to California residents that occurred out-of-state.
- Counts are reported by the month and year the death occurred.
- Indicators are not mutually exclusive.

Indicator Definitions:

- All Indicators are based on the Tenth Revision of the International Classification of Diseases codes (ICD-10).
- Indicators are based on the codes listed as the underlying cause of death.
- The “Any Violent Death” indicator is based on the case definition for the [National Violent Death Reporting System \(NVDRS\)](#) funded by the Centers for Disease Control and Prevention (CDC).
- “Any Firearm Death” includes all firearm deaths of all manners and intents (i.e., homicide, suicide, law enforcement involved, unintentional, and undetermined).
- “Law Enforcement Involved” is a fatal event which involved an act by Law Enforcement. (These are coded in ICD-10 as “Legal Intervention”).

Homicide: X85-X99, Y00-Y09, Y87.1, U01, U02

Homicide by Firearm: X93-X95, U01.4

Law Enforcement Involved: Y35.0-Y35.4, Y35.6-Y35.7, Y89.0

Unintentional Firearm: W32-W34
