# Pre-Registration for the CDPH Pre-Standardization Conferences

The California Department of Public Health (CDPH), Food and Drug Branch (FDB) will be providing in-person Pre-Standardization Conference training for State Standard Candidates and Registered Environmental Health Specialists (REHS) who are active retail food inspectors, working in local retail food protection programs. Each conference is three days long and consists of interactive presentations and classroom activities, focusing on different topics such as Hazard Analysis Critical Control Point (HACCP), Foodborne Illness Risk Factors, Active Managerial Control, etc.

Pre-register using the QR code provided below. Priority registration will be given to State Standard Candidates. Candidates are required to attend one Pre-Standardization Conference prior to scheduling their field Initial Standardization to become a State Standard. A certificate of completion and CEUs will be provided to registered participants after successful completion of the conference.

#### Instructions:

- Step 1: Complete the required prerequisite ("pre") curriculum courses listed in Standard 2, Appendix B-1 of the FDA Voluntary National Retail Food Regulatory Program Standards. Each prospective participant needs to complete this requirement and submit the course certificates of completion to FDBRetail@cdph.ca.gov no later than two weeks prior to attending your selected Pre-Standardization Conference. Failure to do so may impact your registration.
- **Step 2:** Scan the QR code and fill out the pre-registration survey for the conference that you want to attend. Pre-registration does not guarantee a seat.
- **Step 3:** Add <u>FDBRetail@cdph.ca.gov</u> to your trusted senders list to prevent your spam filter from blocking your confirmation email.

### Notes:

- 1. Candidates for CDPH standardization will be prioritized during pre-registration. This training has limited seating. Participants accepted into the training will receive a confirmation email after review of their pre-registration submission.
- 2. You will be notified by email if the course is full.
