

## RAM License Fee Worksheet

This worksheet is provided for your convenience to calculate fees for license applications, annual fees and amendment fees as specified in Title 17, California Code of Regulations, sections 30230 and 30231. An amendment fee is required **only** if you are increasing the possession limits specified on the license.

Use Column A to determine license application fee and current annual fee. Use Column B **only** for an amendment to increase possession limits. **1.** Calculate current annual fee using Column A. **2.** Use Column B to calculate new annual fee using new possession limits.

(5) Specify the requested number of use locations or the number of use locations specified on the license, complete the calculation and use the result in line (6). <div style="text-align: center;">(5) # _____ - 1 = _____</div>																
(6) Perform the following calculation and enter it in the proper column: <div style="text-align: center;">(5) x (4) x 0.2 = (6)</div> For amendment fees, enter the calculated value in Column A and Column B.	(6a)	(6b)														
(7) Add Line 4 to Line 6 and round to the nearest dollar. (i.e., 0 to 49 cents, drop the cents; 50 to 99 cents, add \$1.)	(7a)	(7b)														
(8) If Line 7 is less than \$37,290, enter the value of Line 7. If Line 7 is greater than \$37,290, enter \$37,290. This is your application fee or annual fee.	(8a)	(8b)														
(9) Use only for determining amendment fee due to increased possession limits. An amendment fee is not required if your annual fee is already maximized. Subtract (8a) from (8b) and enter in (9b). This is your amendment fee.		(9b)
