This addendum modifies or adds the following Request for Applications (RFA) documents.

**RFA**

1. **Part I. H, 2; Part I. H, 3; and Part III. A:** Updates have been made to the RFA to indicate that a single or lead entity may propose to serve *two or more* counties if at least one of the county CASHNI scores is 400 or above, the combined projected expectant and parenting female population is 200 or greater, and the combined reach meets the minimum requirements. All other eligibility requirements must also be met.
2. **Part I. J, Table 3:** The key action date for “Q&A Responses Published” has been revised to December 16, 2019.
3. **Part III. H, 2:** An error in a reference to a table has been corrected. The correct reference for minimum education and experience requirements is Table 5.
4. **Part IV. E, 4b:** Language that previously stated that it is not necessary to paginate attachments has been removed. Assembling the complete RFA package **requires** pagination of attachments and the narrative. See response #28 in the posted [Question and Answer document](#) for details.
5. **Part V. B, 4c and Part VI. B, 2, Table 9:** The response instructions and rating factors for item 4c has been updated. See response #16 in the posted [Question and Answer document](#) for details.
6. **Part IX. B, 4:** An update has been made to reference the newly added Appendix 4, Medi-Cal Factor Table: Adolescents.
7. **Part IX. C, 2a:** Table 14 has been updated with regards to the timing and required participants for the Adolescent Sexual Health (ASH) Conference.
8. **Part IX. C, 2c:** This item has been modified to update the required participants for the ASH Conference.
