



Adolescent Sexual and Reproductive Health, Sutter County, 2016



Adolescence is the developmental period from ages 10 to 19. During adolescence and into early adulthood, the brain undergoes the last major period of growth and reorganization, resulting in an increased need for stimulation and changes in social and emotional information processing. Adolescence is a time for youth to explore their identity and values. Often this occurs in the context of peer relationships though parents and other adult figures remain influential. Although the morbidity and mortality rates increase sharply from childhood through adolescence, most youth fare well. Adolescence is a critical time for establishing patterns for a positive adulthood - including an active role in one's reproductive and sexual health.



Adolescent Births In Sutter County

- 72 adolescent births occurred in Sutter County in 2016, representing 0.3% of adolescent births in the state that year. 0.3% of CA females ages 15 – 19 lived in Sutter County in 2016.
- The adolescent birth rate has decreased 61.0% since 2006; the state decreased 61.0% over the same period.
- 52.8% of adolescent births in Sutter County were to mothers who reported a Hispanic ethnicity. The state average was 75.2%.
- 34.7% of adolescent births in Sutter County were to mothers who reported a White race. The state average was 11.2%.
- 59.7% of adolescent births in Sutter County occurred in areas of concentrated poverty. The state average was 55.2%.
