TO: ALL WIC VENDORS
SUBJECT: ANNUAL VENDOR TRAINING REQUIREMENT EFFECTIVE
NOVEMBER 29, 2018

Purpose **Vendor Alert 2018-08 is a notice for the completion of the Annual Vendor Training Requirement.**

The California Department of Public Health / Women, Infants, and Children (CDPH/WIC) Division is notifying all WIC authorized vendors that they must complete and certify their participation in the 2018 Annual Vendor Training. WIC authorized vendors are required to certify participation in the Annual Vendor Training using the Vendor WIC Information eXchange (VWIX) system.

Background Each WIC authorized vendor is required to complete the vendor training on an annual basis. Annual vendor training is completed by retrieving and reading the materials located on the VWIX website. WIC authorized vendors participate in annual training in the form of a newsletter. All WIC authorized vendors must certify their completion and understanding of the annual training materials within 30 days of notification by the Department to complete annual training. Failure to complete the Annual Vendor Training will result in the termination of a WIC authorized vendor's agreement.

Authority All WIC authorized vendors or their designated representatives must participate in annual training provided by the Department as required by Title 7 Code of Federal Regulations part 246.12(h)(3)(xii), Title 22 California Code of Regulations section 40733 and WIC Bulletin Regulations (W.B.R.) section 71800, Vendor Training.

Action for Vendors Between November 29, 2018, and December 28, 2018, all WIC authorized vendors must log into the VWIX system to review and certify participation in the 2018 Annual Vendor Training. WIC authorized vendors are required to complete a statement of acknowledgement indicating that they have reviewed and understand the training materials. WIC authorized vendors will have thirty (30) days to complete and certify their participation in the training. Those who fail to certify may be terminated.
