TO: WIC Authorized Vendors

SUBJECT: Recall of Nutramigen with Probiotic LGG Powder Specialty Infant Formula

**Purpose:**

The California Department of Public Health, Women, Infants and Children Division (CDPH/WIC) is notifying all WIC authorized vendors of a voluntary recall of six batches of Nutramigen with Probiotic LGG Powder specialty infant formula by Mead Johnson Nutrition (Reckitt/MJN), due to potential *Cronobacter sakazakii* contamination.

**Background:**

The affected products are 12.3 oz and 19.8 oz containers with specific batch codes, UPC codes, and “Use by Date” (see table below). No illnesses have been reported, and no other Nutramigen with probiotic LGG Powder specialty infant formula batches or other Reckitt/MJN products are affected.
