INFANTS	INDICATION(S)/DIAGNOSIS
Enfamil NeuroPro EnfaCare 13.6 oz powder	Prematurity or low birth weight
Nutramigen 13 fl oz concentrate	Cow's milk and soy protein allergies, managing colic due to cow's milk protein allergy
Nutramigen with Enflora LGG 12.6 oz powder	Cow's milk and soy protein allergies, in addition to other allergies; GERD and malabsorption
Similac NeoSure 13.1 oz powder	Prematurity and designed to be used as a preterm post-discharge formula
Similac Alimentum 12.1 oz powder	Severe food allergies, sensitivity to intact protein, protein maldigestion, or fat malabsorption
CHILDREN 1 YEAR AND OLDER	INDICATION(S)/DIAGNOSIS
PediaSure Vanilla 8 fl oz Ready-to-Feed	Provides additional calories for children with food restrictions, additional dietary support for children with lactose and gluten intolerance

INFANTS	INDICATION(S)/DIAGNOSIS
Elecare Infant 14.1 oz powder	Dietary management of protein maldigestion, malabsorption, severe food allergies, short-bowel syndrome, eosinophilic GI disorders, GI-tract impairment, or other conditions in which an amino acid-based diet is required
Neocate Infant 14.1 oz powder	Cow and soy milk allergy, protein intolerance; allergy-associated conditions including short-bowel syndrome, eosinophilic GI disorders, malabsorption, GERD, and other GI disorders
PurAmino 14.1 oz powder	Severe cow's milk protein allergy, not effectively managed by an extensively hydrolyzed formula. May also be indicated for multiple food protein allergies in both infants and toddlers
Pregestimil 16 oz powder	Fat malabsorption with or without sensitivity to intact proteins. Conditions in which fat malabsorption or steatorrhea may be associated include cystic fibrosis, short bowel syndrome, intractable diarrhea, and severe protein calorie malnutrition
Similac PM 60/40 14.1 oz powder	Lowered mineral intake needs, such as impaired renal function
Similac Alimentum 32 fl oz Ready-to-Feed	Severe food allergies, sensitivity to intact protein, protein maldigestion, or fat malabsorption. Ready-to-Feed is corn free, indicated for corn allergies in addition to other food allergies.
CHILDREN 1 YEAR AND OLDER	INDICATION(S)/DIAGNOSIS
EleCare Jr., Vanilla 14.1 oz powder	Milk, soy, and/or protein hydrolysate formula allergies or intolerances. Nutritional therapy for severe food allergies, short-bowel syndrome, eosinophilic GI disorders, and malabsorptive conditions
Neocate Jr., Unflavored 14.1 oz powder	Cow and soy milk allergy, protein intolerance; allergy-associated conditions including short-bowel syndrome, eosinophilic GI disorders, malabsorption, GERD, and other GI disorders
