# Contract Standard Formulas on the WIC Card Starting August 1, 2022:

- Must be offered to all formula-fed healthy infants.
- Can be issued by a WIC Nutrition Assistant.

Similac Sensitive 12.5 oz powder	Formula indicated for infants with fussiness, gas, or mild spit-up. It is lactose-free. Standard 20 Cal/oz.	No
Similac Total Comfort 12.6 oz powder	Milk-based, reduced-lactose infant formula. It has partially hydrolyzed proteins. Standard 20 Cal/oz.	No
Enfamil ProSobee 12.9 oz powder or 13 fl oz liquid concentrate	Soy-based formula indicated for infants with feeding issues resulting from sensitivity to milk-based formula. Dairy-free alternative to milk-based formula. Suitable for vegetarian diet and kosher diet preferences. Standard 20 Cal/oz.	No

Pregestimil Nursette 24 Cal 2 fl oz ready-to-feed	For infants with fat malabsorption and who may also be sensitive to intact proteins; contains 55% MCT oil, which is more easily absorbed in infants with GI problems.	Yes
PurAmino 14.1 oz powder	Indicated for infants with multiple food protein allergies. Also suitable for conditions requiring elemental diet such as protein maldigestion, malabsorption, short bowel syndrome and eosinophilic esophagitis.	Yes
PurAmino Junior 14.1 oz powder	Indicated for the dietary management of children with multiple food protein allergies. Iron-fortified, hypoallergenic, amino acid based medical food for the dietary management of children with severe cow's milk protein allergy, not effectively managed by an extensively hydrolyzed formula.	Yes
Similac Alimentum 32 fl oz ready-to-feed	Severe food allergies, sensitivity to intact protein, protein maldigestion, or fat malabsorption. Made with extensively hydrolyzed proteins.	Yes
Similac PM 60/40 14.1 oz powder	Formula for infants who would benefit from lowered mineral intake, including those with impaired renal function.	Yes
