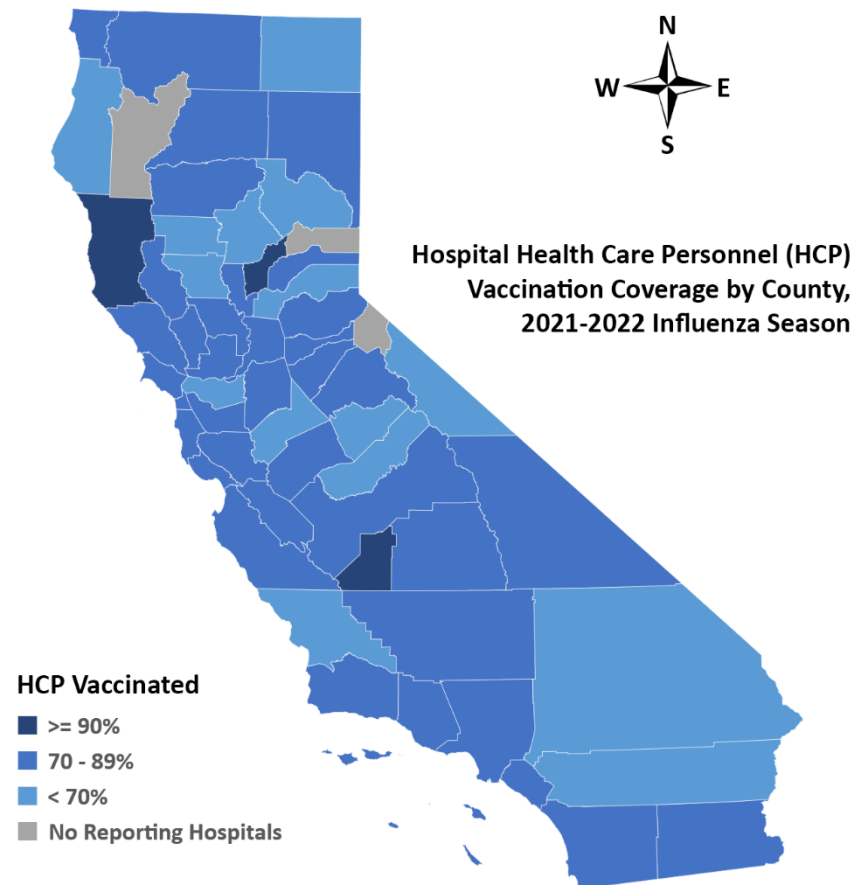

EXECUTIVE SUMMARY

A strong and resilient healthcare delivery system requires healthy workers. Hospital-based health care personnel (HCP) who receive annual influenza vaccination help prevent influenza transmission to patients, their families, and the community. During the ongoing COVID-19 pandemic with the potential for concurrent COVID-19 and influenza outbreaks, it is essential for healthcare facilities to optimize all available effective influenza prevention and outbreak control interventions, including influenza vaccination of HCP.

The U.S. Advisory Committee on Immunization Practices recommends HCP receive the annual influenza vaccine [1]. Additionally, the Centers for Disease Control and Prevention recommends the influenza vaccine as the best way for HCP to protect against influenza infection and transmission [2].

To meet the Healthy People 2020 goal hospital HCP vaccination coverage should have been at least 90% in 2021-2022.

California acute care hospitals must offer influenza vaccination at no cost to HCP, require HCP to receive the annual influenza vaccination or declare in writing that he/she declines vaccination, and report vaccination data to the California Department of Public Health (CDPH) (Health and Safety Code section 1288.7). CDPH is

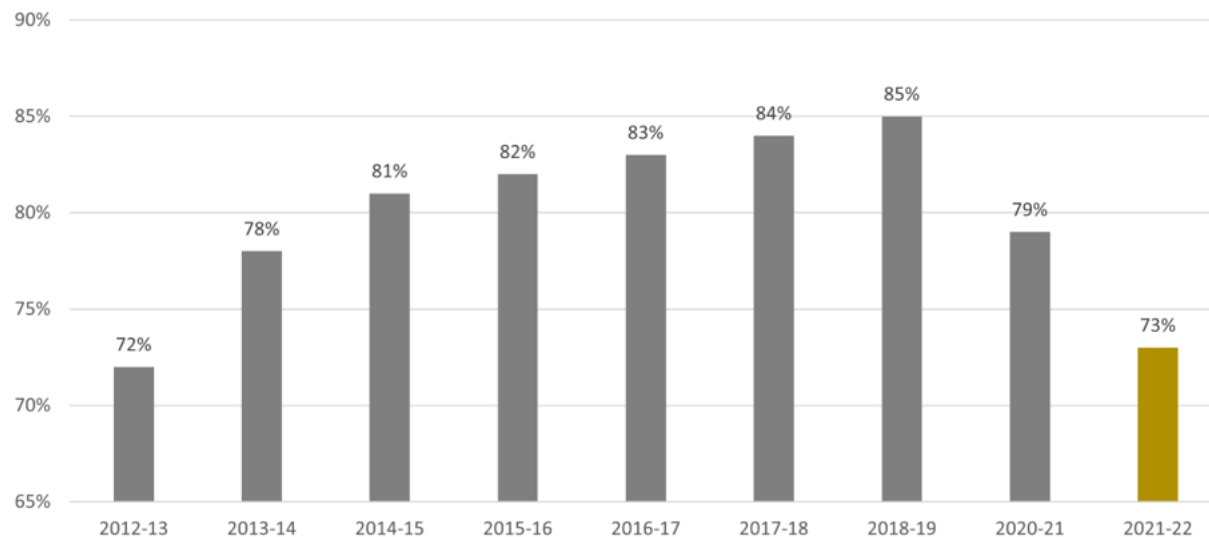
required to publish hospital influenza vaccination coverage no later than six months after receiving the data (Health and Safety Code section 1288.8). This report presents data from 394 California hospitals for the 2021-2022 influenza season (October 1, 2021, through March 31, 2022) and summarizes vaccination coverage by county (Figure 1).

Overall, California hospitals reached 73% influenza vaccination among HCP in 2021-2022 (Figure 2). In total, among

386 reported hospitals, only 64 (17%) hospitals met the 90% Healthy People 2020 goal.

CDPH encourages all persons 6 months of age or older to receive an annual flu vaccine unless they have certain medical conditions that prevent them from getting vaccinated. CDPH suggests members of the public use this report to view vaccination rates of their local hospitals and ask their doctors and other HCP about annual influenza vaccination.

ANNUAL REPORT

BACKGROUND

Influenza circulation generally occurs annually, causing serious consequences especially among high-risk persons. Unvaccinated health care personnel (HCP) who are exposed to persons with influenza in the workplace or community can serve as sources for transmitting influenza virus to co-workers and patients. Many hospitalized patients are at increased risk for influenza complications, such as persons 85 years or older who respond poorly to vaccination, immune-compromised patients and those with certain conditions, and young children [1].

Annual influenza vaccination is a simple and safe strategy for reducing the risk of transmitting influenza. HCP who receives annual influenza vaccination help prevent influenza transmission to patients, their families, and the community. During the ongoing COVID-19 pandemic with the potential for concurrent COVID-19 and influenza outbreaks, it is essential for healthcare

facilities to optimize all available effective influenza prevention and outbreak control interventions, including influenza vaccination of HCP. A hospital's annual HCP influenza vaccination rate is a quality performance indicator of patient safety.

In 2015, the CDPH Healthcare-Associated Infections (HAI) Advisory Committee recommended that all California hospitals achieve the national Healthy People goal of 90% HCP influenza vaccination by 2020 [3]. To meet the 2020 goal, hospitals should have achieved at least 90% vaccination coverage in 2021-2022.

METHODS

This report presents data for the 2021-2022 influenza season, October 1, 2021, through March 31, 2022. State law requires California acute care hospitals to offer influenza vaccination at no cost to HCP and requires HCP to receive the annual influenza vaccination or declare in writing that

he/she declines vaccination (Health and Safety Code section 1288.7). Hospitals collect data for all HCP physically working in the facility for one or more days during influenza season.

Hospitals track HCP vaccination using the National Healthcare Safety Network (NHSN) protocols and report data using the NHSN secure, web-based system [4]. Hospitals provide rights to the California Department of Public Health (CDPH) to receive, analyze, and publish the data. CDPH is required to publish annual HCP vaccination rates within six months of receiving the data (Health and Safety Code section 1288.8). CDPH downloaded the data for this report on May 17, 2022.

The term HCP refers to all paid and unpaid persons working in health care settings who have the potential to be exposed to patients or infectious materials and have the potential to transmit influenza to and from patients

and other HCP. HCP are direct care providers (e.g., physicians, nurses, nursing assistants, therapists, technicians, emergency medical service personnel, pharmacists, laboratory personnel) as well as persons not directly involved in patient care (e.g., clerical, dietary, housekeeping, laundry, security, maintenance, administrative, billing). HCP include employees paid by the health care facility and other professional, contract, and other staff not directly paid by the health care facility. CDPH reports data separately for hospital employees, licensed independent practitioners, contract personnel, and students, trainees, and volunteers.

In 2021-2022, 386 (98%) of hospitals submitted influenza vaccination reports. The CDPH Licensing and Certification Program may cite hospitals with incomplete reporting and require a plan of correction to address the deficiency. Eight (2%) hospitals did not report influenza vaccination data in 2021-2022 (Table 1).

KEY FINDINGS

To reach the Healthy People 2020 goal, statewide vaccination among HCP should have achieved at least 90% in the 2021-2022 influenza season. During the 2021-2022 influenza season, approximately 909,283 HCP worked in California hospitals. Among these

health care personnel, 668,121 (73.5%) received the influenza vaccine.

Influenza vaccination among HCP in California hospitals decreased by 7.6% during the 2021-2022 influenza season

compared with the 2020-21 influenza season (Figure 2).

Overall, of 394 hospitals only 64 (16%) hospitals achieved the 90% Healthy People 2020 goal (Table 2).

Figure 2. Hospital Health Care Personnel Influenza Vaccination Coverage by Year

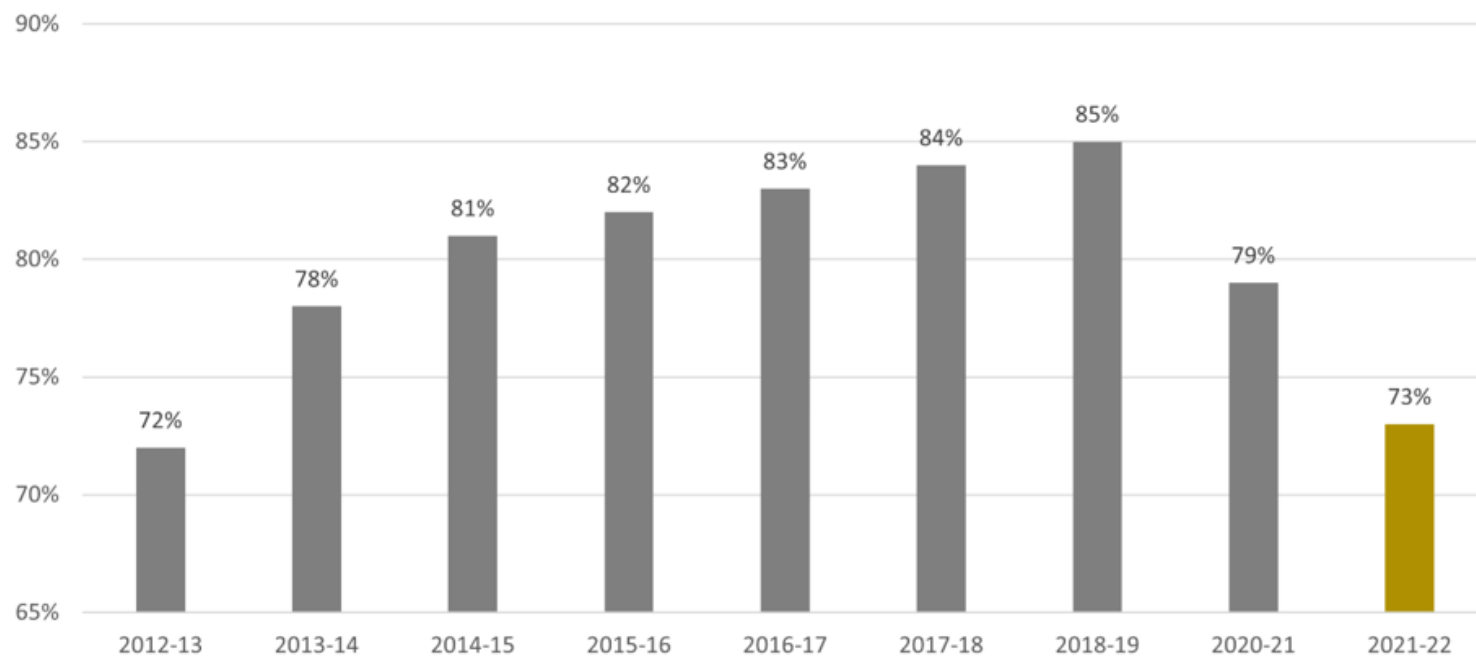


Table 3 shows the list of 81 (21%) hospitals with more than 20% difference in vaccination rate in 2021-2022 compared with 2020-2021. Sixty-eight (17%) hospitals reported more than 20% declining vaccination rate in 2021-2022, while 13 (3%) hospitals reported more than 20% improving

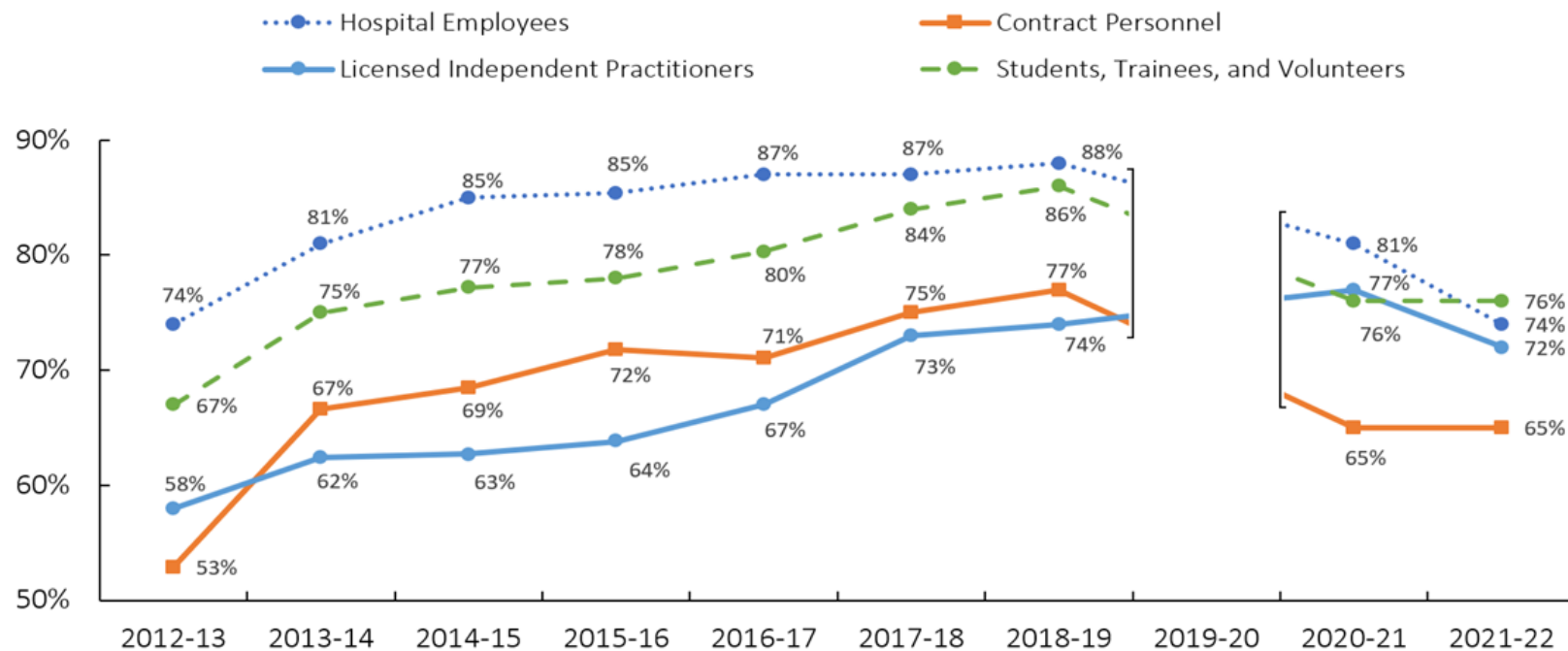
vaccination rate in 2021-2022 influenza season compared with 2020-2021 (Table 3).

Influenza Vaccination by HCP Category

In 2021-2022, 74% of hospital employees received an influenza

vaccine (Figure 3). Influenza vaccination coverage was highest among Students, Trainees, and Volunteers (Figure 3). Contract personnel had lowest influenza vaccination rates among the four HCP categories; none of the HCP categories met the 2020 vaccination goal in 2021-2022 (Figure 3, Table 4).

Figure 3. Influenza Vaccination Coverage by Hospital Health Care Personnel Category, 2012-2022



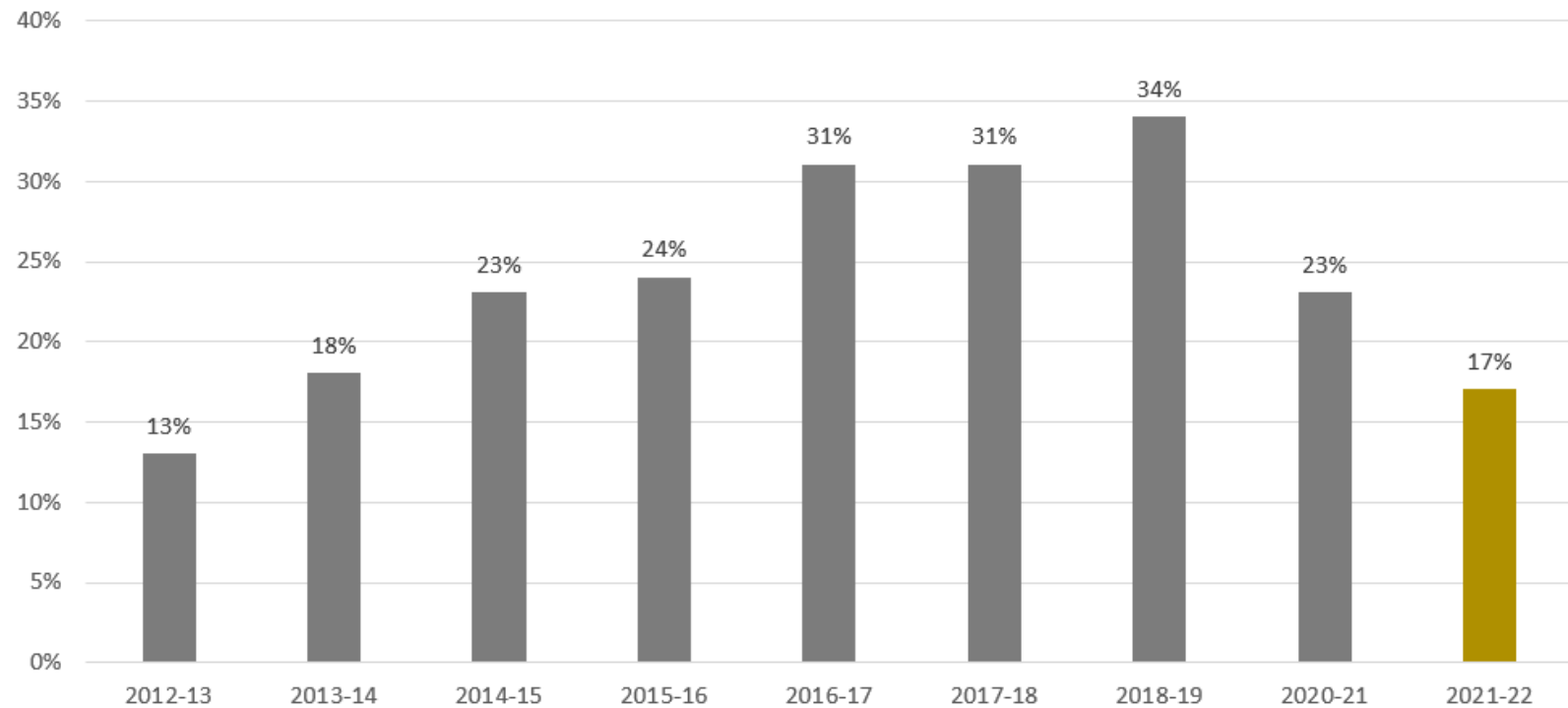
In 2021-2022, 43 (11%) hospitals that reported data for all four HCP categories, achieved the Healthy Peoples target of 90% vaccination coverage among HCP. In addition, 21 (5%) hospitals reporting data for three categories or less, met the target goal

of 90% vaccination coverage among HCP (Table 4).

Influenza Vaccination by Healthy People 2020 Goal Achievement

In 2021-2022, 64 (16%) hospitals met the Healthy People 2020 goal of 90% HCP influenza vaccination, 27% less than the 2020-21 influenza season (88 hospitals) (Figure 4).

Influenza Vaccination by County

In 2021-2022, 3 (5%) counties have met the 2020 goal (Table 5). Prior to the COVID-19 pandemic, forty-one local public health departments issued health orders for their jurisdictions that require HCP who decline vaccination to wear surgical masks during influenza season. However, during the ongoing COVID-19 pandemic universal masking was required for all HCP regardless of their influenza vaccination status. Therefore, the analysis by mask requirement is not included in the 2021-2022 report.

The HCP influenza vaccination rate decreased from 79% HCP vaccinated during the 2020-21 season to 73%

during the 2021-2022 season. Table 4 shows influenza vaccination and unknown percentages for employee and non-employee HCP in California Hospitals, 2021-2022. Unknown vaccination status among employees increased significantly by 75% in 2021-2022 influenza season compared with 2020-21 (14% versus 8%; $p<0.001$), with 72 hospitals (18%) having more than 25% unknown vaccination rate for this HCP category. The findings in this report are subject to the limitation of unknown vaccination status for HCP categories.

Although reasons for the decreased HCP influenza vaccination rate are not

clear, it is possible that universal masking for all HCP may have affected influenza vaccination acceptance since masking requirements for influenza unvaccinated HCP were no longer an incentive [5]. HCP shortages, high rates of absenteeism and use of contracted HCP to mitigate shortages during the pandemic might have contributed to the higher proportion of incomplete documentation [5,6,7].

PUBLIC HEALTH RECOMMENDATIONS

CDPH recommends that all HCP receive annual influenza vaccination. During the ongoing COVID-19 pandemic with the potential for concurrent COVID-19 and influenza outbreaks, it is essential for healthcare facilities to optimize all available effective influenza prevention and outbreak control interventions, including influenza vaccination of HCP. In response to this report, CDPH is providing reminders of the importance of HCP influenza vaccination on weekly healthcare facility calls and webinars, and upon request will provide each local public health agency with a list of hospitals in their jurisdiction that have vaccination rates less than 90% and identify which hospitals should be targeted for local public health intervention.

To improve vaccination coverage in hospitals, CDPH recommends that hospitals:

- Review and provide feedback of vaccination rates to HCP throughout the influenza season


- Target HCP categories with the lowest vaccination rates

CDPH recommends that members of the public:

- Receive annual influenza vaccination if over 6 months of age and older
- Influenza and COVID-19 vaccines can be given at the same time according to Centers for Disease Control and Prevention [8]
- If not sure a family member should be vaccinated due to medical conditions, check with your doctor or other HCP where you receive care
- Discuss the risk of influenza for themselves and their families with their doctor or other HCP
- Ask your doctor or anyone else providing care for you if they have received the annual influenza vaccination.
- When visiting a hospital or other health care facility when influenza is circulating in the community, follow any

instructions for symptoms screening and masking.
