Community and Stakeholder Engagement

- **[Public Health Alliance Regional Equity Learning Collaborative](#)**. The [Public Health Alliance of Southern California](#) launched a [Regional Equity Learning Collaborative \(Alliance Equity Collaborative\)](#) with a two-year, cross-departmental collaborative of public health departments throughout Southern California committed to advancing equity locally and creating a vision for equity for the region. The Collaborative brings together public health leaders from across disciplines, including health and race equity, epidemiology, environmental health, health education, and more. Participants will have the opportunity to learn from public health leaders from across the region, identify promising practices for advancing equity both here in California and across the nation, and co-create solutions in partnership with the communities they serve.

Mental Health Care

- **[Resources to Help Prevent Trauma and Suicide During Catastrophic Events](#)**. [Prevention Institute](#) released [online modules to support communities in understanding recent national trends](#) and use interactive tools to identify local communities at elevated risk for suicide; exploring promising interventions addressing the unique needs of communities at high-risk; understanding how the CDC's technical package and other tools and frameworks can support suicide-prevention efforts; and rapidly assessing local fit and feasibility of best available evidence from CDC's technical package during catastrophic events and beyond.

Longer-term COVID-19 Response Strategies

Cross-sectoral Collaboration and Health in All Policies (HiAP)

- **[COVID-19 Equity Investment Guide](#)**. The [Bay Area Regional Inequities Initiative \(BARHII\)](#) has updated the COVID-19 Rolling Response and Recovery Plan, and created a companion COVID-19 Equity Investment Guide series. This version, updated for the summer/fall of 2021, retains some focus on crisis response, but contains more strategies and principles for an equitable longer-term recovery in light of historic state and federal investments. The investment guide will support local governments in planning for a COVID-19 rolling recovery process that safeguards the health and economic well-being of everyone who calls the Bay Area home.
- **[Analysis on Health and Social Vulnerabilities Across Communities](#)**. The [California Pan-Ethnic Health Network \(CPEHN\)](#) conducted an analysis of California's recent COVID-19 response strategies which relied on Area Based Social Indices tools to address COVID-19 inequities. CPEHN analyzed quantitative data publicly available through the California Department of Public Health, and collected additional qualitative information through interviews with a number of CPEHN's community partners, who helped racially and ethnically diverse Californians receive the COVID-19 vaccine. CPEHN identified fifteen priority recommendations tied to the four findings from the analysis to effectively address and prioritize racial and health equity. - **[Equitable Recovery Efforts Led by Community-Based Organizations Report](#)**. This report, created by the [California Pan-Ethnic Health Network \(CPEHN\)](#), [ChangeLab Solutions](#), and [Prevention Institute](#), with contributions from 21 California Community Based Organizations— provides recommendations for policymakers and community leaders on opportunities to improve California's efforts toward an equitable recovery from the social, economic, and health effects of the pandemic. - **[Local Government Guide for Centering Communities Impacted by Inequities](#)**. The [Bay Area Regional Health Inequities Initiative \(BARHII\)](#)'s latest research-based tool, the [Farther Together Guide](#), is intended to help local governments step up to the growing inequity challenges. This guide provides a plan for public agencies to engage communities in climate resilience planning and disaster response to foster a healthy, resilient future for the Bay Area. It also provides detailed recommendations for policymakers and practitioners on centering communities impacted by inequities. In November, CDPH's Office of Health Equity's [Climate Change and Health Equity Section](#) and the [California Air Resources Board \(CARB\)](#) convened the Public Health Workgroup of the California Climate Action Team (CAT-PHWG) for a workgroup meeting focused on the lessons learned from COVID-19 equity actions, and how they can be leveraged to strengthen climate action planning and community resilience to the health impacts of the changing climate.
