Neisseria Gonorrhoeae (NG) Culture and Antimicrobial Susceptibility Testing (AST) Availability for California Providers

Each year in the United States, half of all gonococcal infections are resistant to at least one antibiotic. Currently, only ceftriaxone is recommended as first-line treatment for gonorrhea. The purpose of this resource is to share with California health care providers which laboratories can conduct NG culture and/or AST, which is recommended for the management of <u>suspected gonorrhea treatment failures</u> and <u>disseminated gonococcal infections</u>.

NG is a fastidious organism that can be challenging to isolate and culture successfully, and not all laboratories are equipped to process specimens. The following is a list of laboratories available to providers working in California that are able to perform both NG culture and AST, NG culture only, or NG AST only.

Providers working for Kaiser Northern and Southern California and Veterans Affairs Health Care should utilize their internal systems for NG culture and AST. Providers in Los Angeles County should contact LA County DPH directly [(562) 658-1300] for further information about NG culture and AST.
