# Adults Living with HIV in California, Medical Monitoring Project 2015-2019

### The Medical Monitoring Project (MMP)

- MMP is a surveillance system funded by the Centers for Disease Control and Prevention and implemented by state and local health departments. It collects behavioral and medical data about people living with HIV in the United States.
- Individuals surveyed were selected from samples of persons with diagnosed HIV aged 18 years and older from the National HIV Surveillance System (NHSS), a census of persons with diagnosed HIV in the U.S. Each year 400 were randomly selected from San Francisco, 400 from Los Angeles county, and 500 from the rest of California. Data were collected via phone or face-to-face interviews and medical record abstractions.
- From 2015 to 2019, MMP interviewed 2,736 adults living with HIV in California. Their responses reflect their experiences during the 12 months before their interview, unless otherwise noted. All data presented are weighted.


### Characteristics of Adults Living with HIV in California 2015-2019

- 86% were male, 12% were female, and 2% were transgender
- 69% were men who have sex with men
- 38% were Hispanic or Latinx,
  36% were White, 17% were Black/
  African American, and 9% were of other race/ethnicity
- 16% had been diagnosed with HIV less than 5 years at the time of their interview
- 36% had private insurance, 55% had public insurance only, 8% had Ryan White coverage only, and 1% were uninsured
- 35% had a household income at or below the poverty line and 12% experienced homelessness



#### **Behavioral and Clinical Characteristics**



MSM = Men who have sex with men; MSW = Men who have sex with women only; WSM = Women who have sex with men; Any Sex = any anal or vaginal sex; Virally Suppressed = all viral loads in past 12 months undetectable or <200 copies/ml; Consistent Condom Protected Sex = consistently using a condom during sex with at least one partner; PrEP = pre-exposure prophylaxis; All sexual behavior information is self-reported.

Substance Use<sup>1</sup>

- 27% were current smokers
- 16% engaged in binge drinking<sup>2</sup>
- 5% used injection drugs<sup>3</sup>

#### **STD Testing Among Sexually** Active Persons in Past 12 Months<sup>4</sup>

- 65% were tested for syphilis
- 51% were tested for gonorrhea
- 51% were tested for chlamydia

#### Influenza Vaccination in Past 12 Months<sup>1</sup>

 75% received an influenza. vaccine
