SUBJECT: **UPDATES TO PrEP-AP ALLOWABLE CLINICALLY ADMINISTERED MEDICATIONS**

Overview

The purpose of this memo is to announce the addition of the meningitis vaccine to the PrEP-AP formulary. This memo also provides an update to the Allowable Clinically Administered Medications that can be billed to the PrEP-AP medical benefit manager, Pool Administration, Inc.

Additions to PrEP-AP Allowable Clinically Administered Medications

PrEP-AP has added the following five meningitis vaccines to the PrEP-AP Allowable Clinically Administered Medications list.

PrEP-AP Allowable Clinically Administered Medications

PrEP-AP provided a list of allowable clinically administered medications (then referred to as Allowable Physician Administered Medications) in Provider Policy Memo (PPM) 2018-01. Updates were made in Management Memo (MM) 2019-06 to add the Hepatitis B vaccine, MM 2019-31 to add the HPV vaccine, and MM 2020-15/PPM 2020-03 to add the Hepatitis A vaccines.



Separately, PrEP-AP provides the list of medications in the “Go-live” packet when a provider clinic joins the PrEP-AP provider network, which provides a comprehensive list of the specific dosages covered. Recently, we have developed an updated, comprehensive list that compiles all of the information into a single document. This PrEP-AP Allowable Clinically Administered Medications list is attached to this memo.

PrEP-AP requests that you share this information with your clinical leadership team and local prescribers. You can reference the enclosed PrEP-AP Allowable Clinically Administered Medications for the most up to date information.
