**NOTICE OF 15-DAY PUBLIC AVAILABILITY OF PROPOSED CHANGES
TO EMERGENCY REGULATIONS AND SUPPORTING DOCUMENTS AND INFORMATION
REGARDING NEWBORN SCREENING - DPH-09-010E

Pursuant to Government Code §11346.8 and California Code of Regulations, title 1, §44, notice is hereby given that the Department has changed the text of the emergency regulations regarding Newborn Screening - DPH-09-010E and has deleted material from the record of the rulemaking proceeding for those regulations. The changed text of the regulations is being made available for public comment prior to adoption, amendment, or repeal of the resulting regulations.
