**NOTICE: SECOND 15-DAY PUBLIC AVAILABILITY  
DPH-10-007 HEALTH AND MEDICAL PHYSICIST AUTHORIZATION**

**PUBLIC PROCEEDINGS:** Pursuant to Government Code section 11346.8(c) and Title 1 California Code of Regulations, Section 44, notice is hereby given that the California Department of Public Health (Department) has changed the text of the proposed regulations regarding Health and Medical Physicist Authorization (DPH- 10-007) and is making the changed text available for public comment prior to adoption, amendment, or repeal of the resulting regulations. These changes are initiated either by the Department or in response to comments that were received during the first 15-day availability public comment period, which began on March 29, 2019 and ended April 15, 2019.

For purposes of Government Code section 11347.1, the document, “Second Supplemental Statement of Reasons,” is added to the rulemaking file, deemed a document relied upon, and designated as **Reference 2**.

A copy of the proposed text with the new changes clearly indicated, and Second Supplemental Statement of Reasons is attached.
