NOTICE OF 15-DAY PUBLIC AVAILABILITY OF CHANGES TO PROPOSED REGULATIONS REGARDING TEMPORARY MANAGEMENT (DPH-11-017)

PUBLIC PROCEEDINGS: Pursuant to Government Code section 11347.1, notice is hereby given that the California Department of Public Health (Department) has changed the text of the proposed regulations regarding Temporary Management (DPH-11-017).

A copy of the proposed text with the new changes clearly indicated is attached.
