**NOTICE OF 15-DAY PUBLIC AVAILABILITY OF CHANGES TO PROPOSED

PUBLIC PROCEEDINGS: Pursuant to Government Code section 11347.1, notice is hereby given that the California Department of Public Health (Department) has changed the text of the proposed regulations regarding Compatibility Maintenance with NRC Regulations, (DPH-24-001).
