Notice of Public Hearing and Extension of the Public Comment Period
DPH-18-015, Syringe Exchange Program Regulatory Consistency

Notice is hereby given the Department of Public Health (Department) will conduct a public hearing at 10:00 AM, April 14, 2021 via Zoom, during which time any interested person or such person's duly authorized representative may present statements regarding DPH-18-015. Additional information regarding the public hearing is below. All other information contained in the public notice for DPH-18-015 which was previously mailed and made available on February 19, 2021 remains the same with the exception of the close of the public comment period which has been extended to May 6, 2021.

The purpose of the public hearing is to receive testimony, not to engage in debate or discussion. At the public hearing attendees wishing to speak will be heard on a first come, first serve basis. Speakers will be limited to five minutes or less. Those wishing to submit public comment in writing may do so by emailing regulations@cdph.ca.gov or may hand-deliver to California Department of Public Health, Office of Regulations, 1415 L Street, Suite 500, Sacramento, CA 95814. The deadline for all comments is May 6, 2021.
