

SMALL WATER SYSTEMS PROGRAM PLAN MONTHLY UPDATE

July 2013

Summary:

The Small Water Systems Program Plan (SWSP) tracks the progress of small water systems that are in violation of a primary constituent MCL by meeting specific milestones. There are a total of **183** community water systems that have between 15 and 999 service connections listed on the SWSP. The total population targeted on the SWSP is approximately 60,000 and the total number of service connections is approximately 18,000. There are eight types of primary drinking water standards that are violated by these systems. The total numbers of water systems that are violating primary drinking water standards are: 107 Arsenic, 61 Nitrate, 11 Uranium, 2 Gross Alpha, 9 Surface Water, 2 Perchlorate, 1 DBCP, and 1 Fluoride (some systems exceed more than one standard).

Progress:

A small water system listed on the SWSP is measured on progress in returning to compliance by meeting specific milestones/goals. These milestones/goals are as follows: issuance of a compliance order, submittal of a universal pre-application for funding, placement on the Safe Drinking Water State Revolving Fund (SDWSRF) project priority list (PPL), invitation for funding, submittal of a statement of intent (SOI) to pursue funding, submittal of a funding application, execution of a funding agreement, and finally, the return of the water system to compliance by solving the problem.

Every unsolved system on the list has met the following milestones:

- Received a compliance order
- Submitted a universal pre-application for funding
- Placed on the SDWSRF PPL and invited for funding

Water Systems Receiving Executed Construction Funding Agreement in July 2013:

Water Systems Solved in July 2013:

- 5400660 – Lake Success Mobile Lodge (Tulare County) – Lake Success Mobile Lodge serves approximately 20 people through 18 connections. The County of Tulare Environmental Health Services Division issued an enforcement action (compliance order/citation) on September 14, 2010, for exceeding the nitrate MCL.

Lake Success installed an ion-exchange treatment system and has returned to compliance. The system did not apply for funding or request technical assistance.

- 5402047 – Gleanings for the Hungry (Tulare County) – Gleanings for the Hungry serves approximately 31 people through 12 connections. The County of Tulare Environmental Health Services Division issued an enforcement action (compliance order/citation) on April 15, 2010, for exceeding the nitrate MCL. Gleanings for the Hungry installed point-of-use devices and returned to compliance when the County amended its permit to approve of the devices. The system did not apply for funding.
- 2701670 – Langley Cyn/Valle Pacifico (Monterey County) – Langley Cyn/Valle Pacifico serves approximately 81 people through 27 connections. The Monterey County Department of Health issued an enforcement action (compliance order/citation) on January 1, 2009, for exceeding the arsenic MCL. The system installed a treatment plant with finished water below the MCL and has returned to compliance. The system did not apply for funding or request technical assistance.
