

# NURSING HOME ADMINISTRATOR EXAMINATION INSTRUCTIONS

**NHAP RESPONSIBILITY**

The Nursing Home Administrator Program must establish and carry out procedures to ensure that licensed administrators comply with federal standards when they serve as a nursing home administrator.

**EXAMINATION CANDIDATES RESPONSIBILITY**

Additionally, it is the responsibility of the potential administrator to be knowledgeable of 42 CFR, Part 483, which identify the requirements for state long term care facilities (SNFs).

**STATE EXAMINATION CONTENT**

The State Examination consists of 100 multiple choice questions. The content of the examination includes the Omnibus Budget Reconciliation Act (OBRA) guidelines, California Code of Regulations, Title 22, Division 5; as well as, the following title or code cites:

- Chapter 2.5, Chapter 3, Article 3 .....30 questions
- Chapter 3, Article 5 ..... 20 questions
- Chapter 3, Article 6, Chapter 4 .....18 questions
- Chapter 4, Articles 1, 2, 3, 4, 5 & 6..... 17 questions

**NATIONAL EXAMINATION CONTENT**

The National Examination consists of 150 multiple choice questions and is prepared by the Professional Examination Service (PES) in New York for the National Association of Long Term Care Administrator Boards. Questions on the examination were created from numerous sources by PES consultants. You will receive a NAB bibliography to refer to.
