CITATION FOR NONCOMPLIANCE

With Total Coliform Monitoring and Reporting for November 2013

Section 116650 of the California Health and Safety Code (CHSC), authorizes the issuance of a citation for failure to comply with a requirement of California Safe Drinking Water Act (CHSC, Division 104, Part 12, Chapter 4, commencing with Section 116270), or any regulation, permit, standard, citation or order issued or adopted thereunder.

The Division of Drinking Water and Environmental Management of the State of California Department of Public Health (Department) hereby issues a citation to the Rued Vineyards (System) for failure to comply with Title 22, California Code of Regulations (CCR) Section 64423, 64423.1, and Citation No. 02-18-13C-063.

APPLICABLE AUTHORITIES

Section 116650 of the CHSC states in relevant part:

- (a) If the department determines that a public water system is in violation of this chapter or any regulation, permit, standard, citation, or order issued or adopted thereunder, the department may issue a citation to the public water system. The citation shall be served upon the public water system personally or by certified mail. Service shall be deemed effective as of the date of personal service or the date of receipt of the certified mail. If a person to whom a citation is directed refuses to accept delivery of the certified mail, the date of service shall be deemed to be the date of mailing.
- (b) Each citation shall be in writing and shall describe the nature of the violation or violations, including a reference to the statutory provision, standard, order, citation, permit, or regulation alleged to have been violated.
- (c) A citation may specify a date for elimination or correction of the condition constituting the violation.
- (d) A citation may include the assessment of a penalty as specified in subdivision (e).
- (e) The department may assess a penalty in an amount not to exceed one thousand dollars (\$1,000) per day for each day that a violation occurred, and for each day that a violation continues to occur. A separate penalty may be assessed for each violation.

California Code of Regulations (CCR), Section 64423 states in relevant part:

(a) Each water supplier shall collect routine bacteriological water samples as follows:

(3) The minimum number of samples for transient-noncommunity water systems using groundwater and serving 1000 or fewer persons a month shall be one in each calendar quarter during which the system provides water to the public.

California Code of Regulations, Section 64423.1 states in relevant part:

(c) Analytical results of all required samples collected for a system in a calendar month shall be reported to the Department not later than the tenth day of the following month.

STATEMENT OF FACTS

This System is a transient-noncommunity water system located in Sonoma County west of Healdsburg serving an approximate population of 35. **The First Citation includes Directive 3:** *“This Water System shall collect one bacteriological water sample per month from the distribution system for the next three consecutive months. Specifically, one bacteriological water sample must be collected in each of the following three months: November/December 2013 and January 2014.”*

1 As of the date of this Citation, the Department has not received results for a
2 routine bacteriological sample collected from the distribution system of
3 Rued Vineyards during November 2013.

5 **DETERMINATIONS**

8 **THE DEPARTMENT HAS DETERMINED:**

9 The System violated Title 22 of the CCR, Section 64423 and 64423.1, and
10 Citation No. 02-18-13C-063, Directive 3, in that the System failed to collect a
11 routine bacteriological from the distribution system of the Rued Vineyards
12 during November 2013.

14 **PENALTIES PURSUANT TO HEALTH AND SAFETY CODE SECTION**

18 The Department hereby assesses upon System a penalty in the amount of
19 \$100.00. Directions for paying this penalty are included in Directive 5 of this

25 Rued Vineyards is hereby directed to take the following actions:

1. Comply with Section 64423 and 64423.1, Title 22, of the California Code of Regulations in all future monitoring periods.

2. Notify all persons served by the System of the monitoring and reporting violation in conformance with Section 64463.4 and 64465, Title 22 of the CCR, and as follows:
 - a) Completion of Attachment A to include the name, address, and telephone number of a System representative as a source of additional information concerning the public notice. **You must also give a legible, written description (preferably typed) of the corrective actions taken by the water system to prevent this violation from occurring in the future. You must use the space provided in Attachment A for this written description.**

 - b) Post the notice contained in Attachment A, **after it has been completed in accordance with (a) above**, in conspicuous locations throughout the area served by the System. Posting must begin no later than **February 10, 2014** and must continue for seven days.

 - c) Publish the notice contained in Attachment A, **after it has been completed in accordance with (a) above**, in a local newspaper of general circulation in the area served by the System (or weekly

1 newspaper if no daily paper is available) for one day. The
2 publication in a local newspaper must be completed by **February**
3 **14, 2014.**

5 d) Complete and submit the enclosed Bacteriological and
6 Groundwater Rule Sampling Plan by **February 20, 2014.**

8 e) Provide public notice for this violation in accordance with Section
9 64465(c), Title 22 or the CCR, which requires for each non-
10 English speaking group that exceeds 1,000 residents or 10% of
11 the residents in a community (whichever is less) that the public
12 notice contain information in the appropriate language(s)
13 regarding the importance of the notice, or contain a telephone
14 number or address where such residents may contact the water
15 system to receive a translated copy of the notice or to receive
16 assistance in the appropriate language.

20 3. This Water System shall collect one bacteriological water sample per
21 month from the distribution system for the next five consecutive
22 months. Specifically, one bacteriological water sample must be
23 collected in each of the following months: **January, February,**
24 **March, April and May 2014.** The results of these samples must be
25 submitted directly to this Department by the analytical laboratory, and
26 they must be received no later than the tenth day of the month
27 following sampling.

4. The System shall complete the attached Compliance Certification form and return it to the Department within 10 days of the public notice being given to the system customers but in no case later than **February 20, 2014**. A copy of the notice published in the newspaper and a copy of the notice posted in the system must be attached to the form.

5. Submit to the Department by **February 20, 2014**, a check for the penalty of \$100.00 imposed by this Citation and a copy of the form, which is attached hereto, entitled "Notice of Citation Issuance." The Citation number shall be written on the check. The check shall be made payable to the California Department of Public Health Safe Drinking Water Account and submitted to:


SEVERABILITY

In addition, the violators may be prosecuted in criminal court and upon conviction, be punished by a fine of not more than \$25,000 for each day of violation, or be imprisoned in county jail not to exceed one year, or by both the fine and imprisonment.

Rued Vineyards Failed to Test for Coliform Bacteria in November 2013

Our water system failed to test the drinking water for coliform bacteria during November 2013. Although this is not an emergency, as our customers, you have a right to know about this violation – what happened, what you should do, and what we did to correct the situation. Please share this information with other people who drink this water, especially those who may not have received this notice directly. You can do this by posting this notice in a public place or giving out copies by hand or mail.

What happened?

We are required by state regulations to monitor our drinking water for specific contaminants on a regular basis. Results of this routine monitoring are an indicator of whether or not the drinking water meets health standards. During November 2013 we did not test for coliform bacteria and therefore cannot be sure of the bacteriological quality of the drinking water during that time.

What does this mean?

Coliforms are bacteria that are naturally present in the environment and are used as an indicator that other, potentially harmful, bacteria may be present. Coliform bacteria are indicators of potential contamination and may originate from human, animal, or soil sources. If the coliform standards are met, the water served can be considered safe from bacteria. If they are not met, drinking the water may not necessarily result in illness, but that possibility exists. Routine and follow up sampling are important to periodically verify the water quality. Our failure to test the drinking water for bacteria during November 2013 was a violation of Section 64423, Title 22 of the California Code of Regulations (CCR).

What should I do?

This is not an emergency. If you have health concerns, you may wish to consult your doctor. General guidelines on ways to lessen the risk of infection by microbes are available from EPA's Safe Drinking Water Hotline at (800) 426-4791.

What corrective actions have been taken to prevent this violation from occurring in the future?

This notification of the public is being done in compliance with Sections 64463.4 and 64465, Title 22 of the CCR as a means of keeping the public informed.
