

Rates were not calculated for transgender persons because information on transgender identity was not consistently collected in 2011.
³ Percent calculations for gender-specific age groups and race/ethnicity exclude individuals for whom age or race/ethnicity was "Not Specified" from the denominator. Caution should be used when interpreting percentages by race/ethnicity, since race/ethnicity information was not reported for the majority of chronic viral hepatitis cases in 2011.



 - These data do NOT measure prevalence or incidence of chronic viral hepatitis infections in California due to the asymptomatic nature of chronic HBV or HCV infections, varied levels of completeness of surveillance reporting, and because it remains unknown how many of the cases described in this report are currently living.


Chronic Hepatitis B – Rates of Newly Reported Cases by Age and Gender, 2011, Sacramento County
