



 - For counties with city health jurisdictions, the data shown include cases from city health jurisdictions; Alameda County includes City of Berkeley, and Los Angeles County includes Long Beach and Pasadena.
 - These data exclude cases reported from state prisons because people are typically incarcerated in a different county than the one in which they would otherwise live.
 - These data do NOT measure prevalence or incidence of chronic viral hepatitis infections in California due to the asymptomatic nature of chronic HBV or HCV infections, varied levels of completeness of surveillance reporting, and because it remains unknown how many of the cases described in this report are currently living.


Chronic Hepatitis C – Rates of Newly Reported Cases by Age and Gender, 2011, Solano County
