Call to Order C. Moss called the meeting to order at 10:05 am.
Welcome, Introductions and Roll Call <ul style="list-style-type: none">• Chair, C. Moss, welcomed all subcommittee members. There were no members of the public in attendance.

Mission The Chair, Carole, reviewed the mission and process of this subcommittee. "The mission of the Environmental Cleaning in Healthcare Subcommittee is to protect the public from healthcare-associated infections by establishing best practices in the area of environmental cleaning in California healthcare facilities."
Update to the HAI-Advisory Committee The Subcommittee discussed CDC best practices for environmental cleaning and monitoring prevention of HAIs. Subcommittee members agreed to include air treatment and water filtration these issues under Phase 2 of their current work. Subcommittee members will review information and empirical research findings on these two new areas and bring their recommendations to future subcommittee meetings.
Discussion and Review The Chair shared the plan for this meeting.

Collaboration begins. Will develop recommendations to present to the HAI Advisory Committee.

Phase 1 – Develop minimum standard requirements and recommendations for California acute care healthcare facilities for environmental cleaning, monitoring, and disinfecting the facility patient care rooms, devices, equipment, and linens. A toolkit will be developed.

The subcommittee previously discussed developing a three-tier approach to environmental cleaning recommendations. At this meeting, members agreed that it would be best if it was a two-tier approach, basic and advanced. It was again clarified that recommendations that result from this subcommittee are not intended for L&C. The objective is to provide guidance to facilities on how to set up a process to clean rooms properly, and to help validate that the correct cleaning process is being performed and results in cleanliness.

Phase 2 – Discussed and determined that CDC recommendations for air treatment and water filtration will be added to the work of the subcommittee in Phase 2 upon completion of recommendations for Phase 1.

The Subcommittee jointly walked through the “Options for Evaluating Environmental Cleaning” published by the CDC Division of Healthcare Quality Promotion, National Center for Emerging and Zoonotic Infectious Diseases.

Action Items

All subcommittee members committed to reviewing the document, finding gaps that need to be included for Phase 1, and be ready to continue with the development of recommendations on June 20.
