 SUBJECT: NOTICE OF **PHASE 2** TO LIFT THE VENDOR MORATORIUM

Purpose The California Special Supplemental Nutrition Program for Women, Infants and Children (California WIC) is announcing the second phase (**Phase 2**) to lift the current federal vendor authorization moratorium effective **September 15, 2014**.

Background In April 2012, the United States Department of Agriculture (USDA) imposed a vendor moratorium, limiting California WIC's ability to authorize new vendor store locations. In June 2014, California WIC received approval from the USDA to begin to lift the moratorium in phases. **Phase 1** was implemented on June 1, 2014, allowing the Program to accept applications from vendors adding additional store locations to an existing WIC contract. Phase 2 Eligibility **Phase 2** allows California WIC to accept new applications from vendors without a current WIC contract that meet the **Full-Line Grocery Store Criteria**. Under WIC Regulatory Bulletin (W.B.R.) Section 50200, a Full-Line Grocery Store is a store that stocks the following varieties and quantities of food:

Food Type(s)	Minimum Varieties Required	Minimum Units Required
Cereal	5 or more varieties	5 or more units of each variety
Breads/Tortillas	4 or more varieties	5 or more units of each variety
Fresh Dairy Products	5 or more varieties	5 or more units of each variety
Fruits and Vegetables	7 or more varieties of fruits <u>and</u> 7 or more varieties of vegetables	5 or more units of fruits <u>and</u> 5 or more units of vegetables of each variety
Fresh Meats/Poultry/Fish	4 or more varieties (includes but is not limited to different cuts of the same type of fresh meat.)	5 or more units of each variety

Action for Vendor

Vendors must meet all eligibility requirements before submitting an application. New vendors meeting criteria for **Phase 2: Full Line Grocery Store** may access instructions and an application package on the California WIC website:
