

□ **Meets basic needs of all**

- Safe, sustainable, accessible and affordable transportation options
- Affordable, accessible and nutritious healthy foods
- Affordable, high quality, socially integrated and location-efficient housing
- Affordable, high quality health care
- Complete and livable communities including affordable and high quality schools, parks and recreational facilities, child care, libraries, financial services, and other daily needs

□ **Quality and sustainability of environment**

- Clean air, soil and water, and environments free of excessive noise
- Tobacco and smoke free
- Preserved natural and open spaces, including agricultural lands
- Minimized waste, toxics, and GHG emissions
- Affordable and sustainable energy use

□ **Adequate levels of economic, social development**

Indicators: Meets basic needs: Healthy transportation options

□ Means of transport

- Motorized connectivity index
- Modal split work, school
- VMT per capita
- % commute trips solo auto
- Daily vehicle hours delay
- % ave income on transportation expense

□ Miscellaneous

- Residential parking ratio

□ Public transit

- Cost/passenger/mile
- % adults who use
- % commuters who use
- % households w/in ½ mile regional bus/ferry

□ Non-motorized transit

- Pedestrian environmental quality index
- Ratio sidewalk/bike lane miles to street miles
- % traffic injuries to cyclists/pedestrians

Indicators: Quality environment:

Air quality

- ❑ Days exceeding 8-hour ozone standards
- ❑ Days exceeding PM standard
- ❑ % households w/in 300 meters major stationary source
- ❑ % households w/in 300 meters roadway
- ❑ # complaints re air quality
- ❑ Toxic air released by permitted facilities

Indicators: Economic/social: Education

- ❑ Educational attainment
- ❑ API scores
- ❑ Per pupil school expenditures
- ❑ % Head Start eligible children unserved
- ❑ Ratio public school population to school-aged population
- ❑ % kindergarten children no school ready
- ❑ High school graduation rate
- ❑ High school drop-out rate

Indicators: social relations:

Safe and supportive relationships

- ❑ Child abuse rates
- ❑ # hate crimes
- ❑ % households w/ children age 2 – 5 where children read to/told stories
- ❑ Homicide rate
- ❑ Property crime rate
- ❑ # police officers/capita
- ❑ Calls to rape crisis center
- ❑ # children in foster care/1000 children
- ❑ # children receiving protective services
- ❑ % reporting experience of discrimination
