Within Section 4.3 – Electronic Submission:

Within Section 5.3 – Contract Award Appeals Procedures:

- o There is no appeal process for applications that are-submitted received late or are incomplete.
- Appeals must be sent by email to <u>LBTQCapacityBuilding@cdph.ca.gov</u> and must be received before 5:00 p.m. on <u>December 19, 2022 January 9, 2023</u> or 5 business days following intent to award is announced, whichever is latest.

Within Section 6.6 – Modifying or Withdrawal of Application:

 An applicant may, by emailing <u>LBTQCapacityBuilding@cdph.ca.gov</u>, withdraw or modify a submitted application before the deadline to-<u>submit_receive</u> applications. Applications cannot be changed after the deadline to-<u>submit_receive applications</u>.
