PUBLIC PROCEEDINGS: Pursuant to Government Code section 11346.8(c) and Title 1 California Code of Regulations, Section 44, notice is hereby given that the California Department of Public Health (Department) has changed the text for the proposed regulations regarding Adverse Events Reporting, DPH-11-023, and is making the changed text available for public comment prior to adoption, amendment or repeal of the resulting regulations.
